REGISTRATION AND PAYMENT CONDITIONS FOR THE INTERNATIONAL MASTER'S DEGREE IN SLEEP MEDICINE

The Fundación Instituto del Sueño (Sleep Institute Foundation), in collaboration with the European University of Madrid, offers this International Master's Degree in Sleep Medicine, 100 % online, with the aim of providing updated theoretical and practical knowledge in the multidisciplinary field of sleep medicine, enabling students to practice and train this medical discipline. As a result of this, the student will obtain a Master's degree from the Universidad Europea.

1. OBJECT. The FUNDACIÓN INSTITUTO DEL SUEÑO (FIS), in collaboration with the UNIVERSIDAD EUROPEA DE MADRID. S.A.U., will provide the student with the educational services for the enrolled master's degree, without prejudice of the provisions of clause 10. The student is obliged to comply with the provisions of these General Conditions of Registration and fully submit to the academic and internal rules issued by the European University, in the exercise of the university autonomy that is their own. As payment of the economic consideration for the mentioned services, the student and the economic responsible that in this case is designated, commit themselves to pay the total amount resulting from the student's matriculation that is reflected in the section information section of the master in the Registration Form.

2. FORM AND TERMS OF PAYMENT. The reservation of a place must be paid in advance through the payment procedure established for this purpose. In no case will the reservation be refunded if no notice of non-enrollment is given more than one month before the start of classes. The certificate of admissions to the master is only granted if the amount corresponding to the reservation has been paid to the Fundación Instituto del Sueño (FIS). This amount will only be refunded if the master is not taught for not enrolling a minimum number of ten students established by the Fundación Instituto del Sueño (FIS). Once being admitted to the master, if for voluntary or involuntary causes, or any other circumstances, either by accident or due to force majeure, the student wishes to cancel, the amount delivered will not be refunded. Such circumstances must be communicated in writing to the Fundación Instituto del Sueño (FIS).

PAYMENT METHOD: Bank Transfer only. Exchange rate. commissions and/or bank transfer fees are at the expense and responsibility of the student or paying body.

GENERAL CONDITIONS:

- A. **Registration:** 1,000.00 euros (approximately 10% of the total price of the master), before February 15th 2024
- B. **Tuition:** 8,000.00 euros. To be paid as follows:
 - i. **One-time Payment:** before the beginning of the program (March 2024) A 3% discount on the tuition (7,760.00 euros) will be applied on the advanced and single payment of the tuition plus the registration (1,000.00 + 7,760.00 euros). To receive the 3% discount, the total amount of the master must be paid before December 2023 (registration and tuition).
 - ii. **Three Installments:** The tuition payment will be made in three different installments: 50% before February 15th, 2024 (4,000.00 euros); 25% by August 15th, 2024 (2,000.00 Euros); and the remaining 25% by December 15th, 2024 (2,000.00 Euros).

3. INTEREST ON LATE PAYMENTS. The amounts owed by the student that are not paid in their corresponding dates will accrue late payment interest in favor of the Foundation at the legal interest rate of the money increased by two (2) percentage points.

4. WARRANTIES. The student is responsible for all the obligations derived from the General Conditions of Enrollment and the obligations that arise from the services provided by both the University and Foundation.

5. DURATION AND CAUSES OF RESOLUTION. The present contract has a duration linked to the period for which the student has registered and enrolled. The Fundación Instituto del Sueño (FIS) may terminate and give up this contract, demanding the immediate payment of the outstanding capital and other amounts that it credits, even if the stipulated period has not elapsed, if the student fails to comply or defectively comply with any of the clauses of this contract or has failed to comply with any other obligation due, liquid and enforceable they have contracted with the Fundación Instituto del Sueño (FIS) for any other concept.

6. DISMISSAL. Only if the registration has been done remotely, the student may cancel the registration contract within 14 calendar days from the formalization of the registration. The withdrawal of the enrollment contract implies the full return of the amount paid for teaching. However, the amount corresponding to the reservation of place is under no circumstances refundable.

7. PAYMENT OBLIGATIONS. The student is responsible for the payment of all the expenses that could be produced for the fulfilment of what was agreed in this contract, including banking expenses, lawyers, and attorney's fees. If the student decides unilaterally to abandon his or her studies, he or she must notify the Fundación Instituto del Sueño (FIS), either in writing by certified mail (Paseo de la Habana 200, 28036 Madrid, Spain), or by e-mail to pzi@iis.es. In the case that the student unilaterally abandons his studies and does not notify it in writing, the student will be obliged to pay the amount corresponding to the academic fees of the current months if he does not accredit his situation of cancellation.

8. CONSEQUENCES OF FAILURE TO PAY. Failure to pay the total or partial amount due will result in the refusal or cancellation of the registration and consequently the loss of the student's status for the master's program. The loss of student status makes it impossible to take and grade any of the evaluation tests. The University and the Fundación Instituto del Sueño (FIS) will refuse to issue degrees, certificates, and transfers when students have pending payments, establishing on those amounts a surcharge corresponding to the interest on arrears referred to in the clause on interest on arrears of these general conditions. In case the student pays the debt contracted during an academic year before the end of the same one, the subjects pending of qualification at the time of cancellation will be qualified according to their performance during the period in which the file was active. Should the student pay the debt incurred after the end of the academic year, the subjects pending of qualification at the time of the cancellation will appear in the academic record as "Canceled Call". The student waives the right to any individual notification if the Fundación Instituto del Sueño (FIS) (Paseo de la Habana 200, 28036 Madrid, Spain), makes a transfer or sale of all or part of the outstanding debt, or the actions derived from it.

9. CHANGE OF ADDRESS. The student is obliged to communicate reliably to the Fundación Instituto del Sueño (FIS), any change of address or e-mail that could take place during the academic course, and that for effects of notifications, it is the fixed one in the application of matriculation. This can be done in writing to the Fundación Instituto del Sueño (Paseo de la Habana 200, 28036 Madrid, Spain) or by email to pzi@iis.es

10. REGISTRATION. The registration of the student will be formalized either personally in writing or by electronic means. For this purpose, the University gives the student, who declares to receive at this time, his user number and password that will serve during his stay as a student at the University as a means of personal identification for the student. This user number and password constitutes the electronic signature of the student, personal and non-transferable, and the student accepts it to register by internet, as well as to know the status of his or her file, and if applicable, to make requests, request certificates or any other use that the University makes available to him or her by electronic means. The student agrees to the personal and non-transferable use of the electronic signature. The University is not responsible for the misuse of the signature by the student in all matters related to his or her academic record. The University will claim for any damages caused by the misuse of the electronic signature by the student. The Fundación Instituto del Sueño (FIS) reserves the right not to teach the master or to delay its start if a minimum number of 10 students is not reached, in which case any payments will be returned in full. The student will be duly informed of these circumstances. The schedules of the classes and the practices, as well as those of the tests of evaluation, will be determined by the Fundación Instituto del Sueño (FIS), having the students to adjust to them according to the groups in which it is enrolled.

11. INTERNAL REGULATIONS OF THE UNIVERSITY. Given that the master is carried out in collaboration with the European University, the student expressly declares to accept and to know the Internal Regulations of the European University of Madrid and its academic regulations to which he or she is subject, due to his or her condition as a student, during the whole time of his or her link with the University. 12. TREATMENT OF PERSONAL DATA.
