**SPANISH SLEEP FOUNDATION**  
**REGISTRATION AND PAYMENT CONDITIONS FOR THE SLEEP MEDICINE MASTER**

The Spanish Sleep Foundation, through the Sleep Institute and in collaborations with the European University of Madrid, offers a completely online master in Sleep Medicine with the aim of providing updated theoretical and practical knowledge about sleep medicine, enabling students to practice and train this medical discipline.

**1. OBJET.** The Spanish Sleep Foundation, in collaboration with the UNIVERSIDAD EUROPEA DE MADRID. S.A.U., will provide the student with the educational services for the enrolled master's degree, without prejudice of the provisions of clause 10. The students are obliged to comply with the provisions of these General Conditions of Registration and fully submits to the academic and internal rules issued by the European University of Madrid, in the exercise of the university autonomy that is their own. As payment of the economic consideration for the mentioned services, the student and the economic responsible that in this case is designated, commit themselves to pay the total amount resulting from the student's matriculation that is reflected in the section information section of the master in the Registration Form.

**2. FORM AND TERMS OF PAYMENT.** The reservation of a place must be paid in advance through the payment procedure established for this purpose. In no case will the reservation be refunded if no notice of non-enrolment is given more than one month before the start of classes.

The certificate of admissions to the master is only granted if the amount corresponding to the reservation has been paid to the Spanish Sleep Foundation. This amount will be refunded if the master is not taught for not enrolling the minimum number of six students established by the Spanish Sleep Foundation. Once having been admitted to the master, for voluntary or involuntary causes, for other circumstances, either by accident or due to force majeure, the student wishes to cancel, the amount delivered will not be refunded and must communicate such circumstances in writing, addressed to the Spanish Sleep Foundation.

**Terms of Payment:**

- Bank Transfers. The commission and/or expenses of the bank transfer is responsibility of the student or paying body.
- Credit Card

**General Conditions:**

- A. **Registration and Tuition:** 715 euros (10% of the total price of the master).
- B. **Teachings:** 6.435 euros. Paid as follows:
  - i. One-time Payment. 3% discount for the single payment on full of the entire master's degree program (6.241,95 euros). In order to receive the 3% discount, a deposit of the total amount must be made before December 30th, 2020 (registration and teaching).
  - ii. Three Installments: The teaching payment will be made in three different installments of 50% before February 2<sup>nd</sup>, 2021 (3,217.00 euros), 25% by August 15<sup>th</sup>, 2021 (1,608.75 Euros), and the remaining 25% by December 15<sup>th</sup>, 2021 (1,608.75 Euros).

**3. INTEREST ON LATE PAYMENTS.** The amount owed by the student that are not paid by their corresponding dates will accrue late payment interest in favor of the company at the legal interest rate of the money increased by two (2) percentage points.

**4. WARRANTIES.** The student is responsible for all the obligations derived from the General Conditions of Enrollment and the obligations that arise from the services provided by both the university and foundation.

**5. DURATION AND CAUSES OF RESOLUTION.** The present contract has a duration linked to the period for which the student has registered and enrolled. The Spanish Sleep Foundation may terminate and give up this contract and demand the immediate payment of the outstanding capital and other amounts that it credits, even if the stipulated period has not elapsed, if the student fails to comply or defectively comply with any of the clauses of this contract or has failed to comply with any other obligation due, liquid and enforceable they have contracted with the Spanish Sleep Foundation for any other concept.

**6. DISMISSAL.** Only if the registration has been done remotely, the student may cancel the registration contract within 14 calendar days from the formalization of the registration. The withdrawal of the enrollment contract implies the full return of the amount paid for teaching. However, the amount corresponding to the reservation of place is under no circumstances refundable.

**7. PAGOS EXIGIBLES.** The student is responsible for the payment of all the expenses that could be produced for the fulfilment of what was agreed in this contract, including banking expenses, lawyer's, and attorney's fees. If the student decides unilaterally to abandon his or her studies, he or she must notify the Spanish Sleep Foundation, either in writing by certified mail (Paseo de la Habana 200, 28036 Madrid, Spain), or by e-mail to [secretaria@fundacionspanoladelsueño.org](mailto:secretaria@fundacionspanoladelsueño.org). In the case that the student unilaterally abandons his studies and does not notify it in writing, the student will be obliged to pay the amount corresponding to the academic fees of the current months if he does not accredit

his situation of cancellation.

**8. CONSEQUENCES OF FAILURE TO PAY.** Failure to pay the total or partial amount due will result in the refusal or cancellation of the registration and consequently the loss of the student's status for the master's program. The loss of student status makes it impossible to take and grade any of the evaluation tests. The University and the Spanish Sleep Foundation will refuse to issue degrees, certificates, and transfers when students have pending payments, establishing on those amounts a surcharge corresponding to the interest on arrears referred to in the clause on interest on arrears of these general conditions. In case the student pays the debt contracted during an academic year before the end of the same one, the subjects pending of qualification at the time of cancellation will be qualified according to their performance during the period in which the file was active. Should the student pay the debt incurred after the end of the academic year, the subjects pending of qualification at the time of the cancellation will appear in the academic record as "Canceled Call". The student waives the right to any individual notification if the Spanish Sleep Foundation (Paseo de la Habana 200, 28036 Madrid, Spain), makes a transfer or sale of all or part of the outstanding debt, or the actions derived from it.

**9. CHANGE OF ADDRESS.** The student is obliged to communicate reliably to the Spanish Foundation of the Dream, any change of address or e-mail that could take place during the academic course, and that for effects of notifications, it is the fixed one in the application of matriculation. **10. REGISTRATION.** The registration of the student will be formalized in writing in person or by electronic means. For this purpose, the University gives the student, who declares to receive at this time, his user number and password that will serve during his stay as a student at the University as a means of personal identification for the student. This user number and password constitutes the electronic signature of the student, personal and non-transferable, and the student accepts it to register by internet, as well as to know the status of his or her file, and if applicable, to make requests, request certificates or any other use that the University makes available to him or her by electronic means. The student agrees to the personal and non-transferable use of the electronic signature. The University is not responsible for the misuse of the signature by the student in all matters related to his or her academic record. The University will claim for any damages caused by the misuse of the electronic signature by the student.

The Spanish Dream Foundation reserves the right not to teach the master or to delay its start if a minimum number of 6 students is not reached, in which case the payment will be returned in full. The student will be duly informed of these circumstances. The schedules of the classes and the practices, as well as those of the tests of evaluation, will be the predicted ones by the Spanish Foundation of the Dream, having the students to adjust to them according to which it is enrolled.

**11. INTERNAL REGULATIONS OF THE UNIVERSITY.** Given that the master is carried out in collaboration with the European University, the student expressly declares to accept and to know the Internal Regulations of the European University of Madrid and its academic regulations to which he or she is subject, due to his or her condition as a student, during the whole time of his or her link with the University. **12.
